## Committee agenda for 2022-23 agreed at the fall planning meeting

- Final editing and completing recommendations for our White Paper on academic integrity, surveillance during testing of students, and ethical implications ready for Winter Plenary 2023
  - Committee submitted the white paper at Winter Plenary 2023
- 2. The Mediation and Resolution Service report on findings for SUNY Cortland are continuing the pilot program on mediation/ombuds committees, faculty led for faculty at the Winter Plenary 2023
  - Findings on the SUNY Cortland presented at Winter Plenary 2023
- 3. Research and writing a green paper on faculty and staff well-being and the ethics of working and living well in the SUNY Community
  - Met in October and two subcommittees finalized, one looking at the background of the issues the second in researching our SUNY Campuses
  - Met in November, we discussed general focus of green paper, subcommittees met to discuss steps forward in data collection.
  - Divided subcommittees met separately in Februrary 2023 to address background research on burnout and campus wellbeing in Higher Ed (Group 1) and Data collection on SUNY Campuses (Group 2)
  - Data collection so far includes campus surveys and qualitative interviews with stakeholders on home campuses to help define individual issues of ethics and wellbeing in SUNY. We are now in the process of data analysis.

- Final meeting of the year in April included the entire committee included a discussion on progress made. The committee explored next steps on data analysis and summaries for next year.
- We hope to finish the green paper early next fall which will then be the foundation of a white paper and resolutions to address this ever growing complicated problem in SUNY and connect to the importance of ethnics of working and living well in SUNY Community next year.
- 4. Committee is losing its long-term former Chair Andy Fitz-Gibbon and three-year representative Marina Tsiabou who is timing out. I want to express my gratitude to them for their important contribution, as well as an overall thanks to the committee who were themselves facing issues of burnout as they explored these important issues.
