#### **Committee Accomplishments this year**

1. SUNY Graduate Research Conference. The committee has been working with the Center for Professional Development (CPD) at SUNY (Michaela Rehm and Meghan Martin) to organize a second SUNY-wide virtual graduate student research conference. The conference was successfully held on April 11, 2023 between 10am and 3pm. The goals of the conference were to provide graduate students the opportunity to present their research to a diverse audience and to serve as a catalyst to increase collaborations within the SUNY system by providing a virtual meeting space for faculty and students from across the SUNY system. This was the second edition of this conference and built on the success and experience of the 2022 first edition of this conference. The conference was again organized with the logistical support of

the SUNY Center for Professional Development (CPD) and was advertised to all campuses to solicit presentations from graduate students, and attendance by faculty, administrators, staff, and students who may be interested in pursuing graduate education at SUNY. While in 2022, the conference featured graduate students' oral presentations and posters, this year we innovated by organizing panels centered on Big Ideas crossing discipline boundaries and associated with high impact questions of potentially large societal impact and payoff. This year the conference featured 59 graduate students' submissions, in the form of posters panel contributions, two panels, and speaker. Distinguished Research Professor Kenneth Dill from Stony Brook University delivered the address on the topic of the physico-chemical origin keynote The first panel, about Artificial Intelligence (AI) for Good, featured the research of three graduate students and was moderated by Professor Bichindaritz from Oswego. The second panel, about Gender Violence around the World, featured the research of three graduate students and was moderated by Distinguished Professor Tiantian Zheng from Cortland.

Finally six parallel rooms featured groups of poster presentations grouped by themes such as Arts, Education, Biomedical Informatics, Earth Sciences, Medical Sciences, Psychology, and STEM.

The conference has been recorded and the recordings will be posted on the conference Website for future viewing, which should further increase its reach (<a href="http://suny.edu/gradcon">http://suny.edu/gradcon</a>). Furthermore, graduate students are encouraged to post their posters in the SOAR Institutional Repository and an abstracts booklet will be placed in SOAR by the Committee. By bringing together students and faculty from across the State, the Graduate Research Conference (GRC) created a dynamic and innovative networking space and contributed to developing the synergistic power of the SUNY system.

2. Research Resources Advertisement and Enhancing Research Reputation and Productivity across SUNY Campuses. A subcommittee was tasked with the goal of expanding the SUNY provided training seminars for the Sciences that help graduate students write grants to more disciplines and in particular to the Humanities and Social Sciences. Professor Stapleton from the University of Buffalo (UB) shared information about a grant workshop designed for graduate students in the Humanities organized by Adam Capitanio. Although this workshop was restricted to UB students this year, it could become available SUNY-wide in the future and enhance SUNY's research and training of graduate students. The Committee also made progress collecting research resources and equipment from across SUNY.

3. <u>DEIS Support for Graduate Education</u>. A subcommittee was tasked with collaborating with the EID Committee on a resolution on DACA support. Other actions considered were the continuation and extension of the PRODIG program, facilitating educational pathways throughout the SUNY system, and writing a white paper in support of DEISJ in graduate education and research.

4. Incentive Programs for Cross Campus Research. After soliciting the final report on the Networks of Excellence Initiative, the Committee crafted a resolution for the restoration of incentive programs for cross-campus research collaboration. The rationale for this resolution builds on the positive outcomes of the Networks of Excellence in terms of bringing researchers together from the entire SUNY system in collaborative workshops and of providing experiential learning opportunities for graduate students. The Committee advocates that It would therefore be worthwhile to reinstate funding for these initiatives and thus make progress in addressing some of the big societal challenges of our time and benefit society. To further facilitate cross-campus research, the proposed resolution addresses the need to create a SUNY-wide high performance computing (HPC) infrastructure that would enable SUNY campuses to harness the Big Data revolution, which now spans across all disciplines, and empower all students and faculty members to share and process large volumes of data at high speed.

The Committee has started to gather best practices.
