- Worked with Yvette Roberts: UFS passed two resolutions:
 - 179-01-01; Resolution to Include Non-Tenured and Non-Tenure Track Faculty for the Chancellor's Award in Faculty Service.
 - 179-02-01; Resolution to Include Non-Tenured and Non-Tenure Track Faculty for the Chancellor's Award in Scholarship and Creative Activities
- Worked with Yvette Roberts: Shared Governance Award Review and Selection Committee.
 - Dr. Bringsjord and Yvette support the recommendation of a representative from the UFS Programs and Awards Committee serving in an ex-officio capacity on the Shared Governance Award Review and Selection Committee starting academic year 2018-2019.
