Summary of Committee Actions Since Initial Fall Report

- a) At the Fall Planning Meeting, we began our review of the Distinguished Faculty Ranks Policies and Procedures. A Google Doc for all of us to continue and complete our review. The goal is to finish our review of the document by December 15, 2022.
- b) The committee received concerns regarding the Chancellor's Award Policies and Procedures from SUNY Delhi. We revisited these concerns but decided unanimously that no revisions were necessary. The committee crafted a response that I distributed to the relevant stakeholders. During our discussion of the Chancellor's Award, the committee recommended that the deadline for applications be moved to early December.
- c) Out of a conversation at the Executive Committee meeting we brainstormed ideas to increase the number of applications for the Shared Governance Award. We generated five ideas based around word of mouth: 1. Share at planning meeting. 2. Encourage senators to share on individual governance page. 3. Ask CGLs to fill out interest form to Yvette. 4. FCCC liaison will share at FCCC plenary. 5. Announce simultaneously to campus presidents and CAOs.

- d) The Conversations in the Disciplines program has been discontinued through 2023. However, the committee has decided to draft a resolution to request the restoration of funds for the Conversations in the Disciplines.
