Virtual Monthly Meetings on Friday Afternoons

Proposed/Ongoing Actions:

1. We will work to explore consistency across SUNY relative to student's access to 24-hour information access.
 - a. Financial aid concerns
 - b. Mental health counseling
 - c. Legal services for a narrow pool of issues (such as landlord/tenant matters, public assistance issues, basic advocacy, and basic legal guidance)
Further, we will determine if there are COVID developed remote options in these areas. To this end, we will also follow up on the relevant prior work of other committees, such as the 2017 two-part resolution from the Operations Committee, which includes:
 - d. Faculty being informed enough about financial aid so that they can help direct students on these concerns.
 - e. System providing a means of automatically notifying students of relevant issues.

Aspirational Actions:

1. Collaborate with other standing committees on resolutions
 - Preferred pronouns
 - Title IX concerns about the application of standards and policy consistently across campuses
 - Participation in cross-committee ad hoc subcommittees

We will create subcommittees as needed, and we have committee members willing to participating in cross-committee collaborations.

We have a recent SUNY graduate who serves as our system liaison, so we have a student voice to enhance the committee.

Participate in initiatives put forward by the Faculty Council of Community Colleges.

Attend plenary sessions of the body.
