Supporting Students Through Federal FAFSA Delays

- The U.S. Department of Education's launch of the new "Better FAFSA" has led to delays for students and families filling out the form and for campuses to receive the information they need to assemble financial aid packages
- Even as ISIR data has begun to flow to campuses, it has been slow and flawed
- Families need time to understand their financial aid packages before committing to attend a college, and SUNY is committed to supporting all students in getting the financial aid they are eligible for and finding their place at SUNY
- We have added FAFSA information sessions at all campuses throughout the spring and provided guidance to campuses to:
 - Extend any deposit deadline for Fall 2024 enrollment to no earlier than May 15
 - Do everything possible to ensure there are no reductions in Pell enrollments in the Fall 2024
 - Ensure there is no delay in reviewing and determining
 Educational Opportunity Program (EOP) financial eligibility.
 - Communicate, communicate, communicate...
