**Dear Members of the New York State Conference of the U.S. House,**

As leaders of faculty, administrative, and trustee governance organizations for the State University of New York (SUNY), we urge you to **vote NO** on the so-called “One Big Beautiful Bill Act” (or federal budget reconciliation “megabill”) in its entirety. This sweeping legislation is deeply flawed—and nowhere more dangerous than in its higher education provisions.

**This bill attacks opportunity.** It slashes access to Pell Grants, eliminates subsidized loans, and imposes rigid borrowing caps that would force working-class students to abandon dreams of becoming doctors, teachers, engineers, and public servants. It punishes students for earning scholarships and penalizes those who attend college part-time while balancing jobs or caregiving responsibilities.

**It rewards exclusion over access.** By forcing colleges to repay student debt, the bill incentivizes schools to avoid enrolling high-need students—the very people public institutions are meant to serve. At the same time, it guts protections that shield students from fraud and predatory institutions.

**It undermines public colleges that power the American dream.** In New York, SUNY’s 64 campuses—including 30 community colleges—serve over a million students from every corner of the state. The proposed changes would destabilize these institutions and hurt the students and families who rely on them to build better lives.

**This bill doesn’t fix a broken system—it breaks what still works.** And it does so at the expense of students, families, and the workforce of tomorrow.

**Please vote no on the One Big Beautiful Bill Act.** Public higher education isn’t the problem. It’s one of the last engines of opportunity we’ve got. Don’t shut it down.
